#### **Review of Proposed Election Revision Letter**

The proposed election revision letter was distributed to each member of the Board for review. The letter explains the oversight from the Annual Meeting voting conflict with Bylaws Article 2.8:

Voting Requirements. An Owner shall be deemed to be in "good standing" and "entitled to vote" at any annual meeting or at any special meeting of the Association if, and only if, he shall be in full compliance with all of the terms, covenants, and conditions of the Project Documents, and shall have fully paid all Assessments due.

The letter also addresses the process by which a special meeting of the Board was held on October 30, 2019 and the decision to follow Attorney John Richards legal council to remove the votes of the residents with unresolved compliance issues. A recount was conducted by staff at Richards Law. Attorney Richards maintained custody of the ballots from the Annual Meeting in addition to the sign in sheet and the current list of non-compliant homeowners. The new Board members are listed.
